TRIBUNE ARTICLE (5th July, 2013) - WATER LOSSES STILL ON THE RISE

The Corporation takes exception to the article appearing in this morning daily. WSC notes that on occasion, there may be minor inaccuracies in reporting when statements or comments are shared. However, WSC finds the Tribune's article on "Water Losses Still on the Rise" to be misleading, and issues the following statement:

WSC's COMMENTS

- At no point was it expressed that WSC is "unable to explain" the increased water losses
 and in fact the article itself goes on to identify sources of losses discussed during the
 interview. The Article also implies that despite a year and a half having past since the
 award of a contract to reduce water losses, losses continue to increase.
- 2. The contract signed in 2012 with Miya will reduce water losses from nearly 6.5Million gallons per day to less than 2.5Million gallons per day over five years (the reduction phase). The first ten (10) months of the project were dedicated to performing the necessary studies and analysis, as has been reported numerous times in the Press through statements by WSC, and that the necessary controls and infrastructure work were set to start January of this year.
- 3. Water losses have been increasing steadily over several years, and it is unrealistic to believe that the level of leakage which has taken decades to reach will immediately be controlled and reduced overnight.

The Water and Sewerage Corporation wishes to advise the public, its customers and residents in New Providence that water conservation measures will be implemented to assist in building our storage levels. These cutbacks are scheduled to occur between the hours of 10:00 PM and 5:00 AM. During this period, customers in New Providence may experience lower than normal pressures. The Corporation apologies for any inconvenience that may be caused, and appreciates your support as we work to improve our level of service

WSC is committed to improving service reliability and efficiency, and while there will be periods where that service is compromised, we continue to move forward with the necessary improvements to minimize those occurrences.
